HORSE SHOW'S RESPONSIBILITY

1. HORSE SHOW FEES:

- a. **\$35/show** - if results are emailed as USEF electronic results
- b. **\$30/show** - if results are emailed from ShowPro as PEL OrgPro compatible results. This must be set up in your ShowPro software.

Results will not be processed until payment is received

2. RESULTS:

- a. RESULTS MUST BE COMPLETE AND SUBMITTED FROM A HORSE SHOW SOFTWARE:
 - i. PEL in the title of each class that points are to be awarded.
 - ii. Horse's Name, Owner Name and Rider's Name.
 - iii. If classes are combined or offer points in 2 different PEL divisions, the results MUST indicate which section points are to be awarded for each horse/rider.

Show or Class results not received within 45 days of the conclusion of the show will be considered to have been canceled.

3. **COMPLETED FORMS:** Completed Membership Forms, Membership Fees and Horse Registration forms must be received in the PEL office within 2 weeks from the completion of the show.
4. **RULES & SPECIFICATIONS:** League specifications must be posted at the Show Office for exhibitors. Each class must follow the rules and regulations as set forth in the Specifications.
5. **PRIZE LIST MUST INCLUDE:**
 - a. The Princeton Equestrian League logo and/or PEL name in the prize list where all other organizations are listed.
 - b. Each class title and/or specification must have what PEL division points will be awarded.
 - c. The Princeton Equestrian League Advertisement (download from princetonequestrianleague.com)
6. **PEL PROMOTION:**
 - a. Make the following available to all exhibitors and trainers: the most current membership form, horse registration form, PEL Rules and Specifications and any other promotional materials made available to the horse show.
 - b. Public Announcements for PEL during each day of the event.
